Sydney Amateur Sailing Club COMMODORE'S REPORT FOR 1998/99

I am pleased to present my first and the Club's 127th Annual Report.

The financial results for the year have again shown a profit with a reasonable increase in our cash reserves. These results were achieved in spite of some heavy cash outflows on the Club's boats and the pontoon. The maintenance of a reasonable level of cash is important due to the large amounts that will need to be spent on both the recladding of the clubhouse and other major expenditures. It is intended that the planning for the recladding will begin as soon as we have negotiated our new lease. Our Immediate Past Commodore has continued to monitor the progress of the lease.

The Club activities have continued to be conducted in the usual professional manner with a full program of racing and social events. It was exceedingly disappointing that the Daydream Shield had to be cancelled, but hopefully we can win it next year. It is interesting to note that a number of other yachting associations have asked our Club to conduct their championship events, all of which have been successfully concluded. The slipway continues to be operated in a satisfactory manner, and your Vice Commodore continues to seek ways for further improvement.

The "Spirit of the Amateurs" continues to be evident with some significant voluntary efforts during the year. Whether it be the conduct of Racing, Mother's Day at the Wharf, the refloating of the pontoon, the removal of Club engines and maintenance of the Club boats, there is always an army of volunteers ready to help. To recognise the contribution of a Club Member during the year, the Board has agreed to make an annual award to a non Board Member who has made a significant contribution to the Club's activities. This year the award for "Club Member of the Year" was shared by Trevor Cosh and young Jim Lawler for their outstanding effort in refloating the pontoon.

The year saw the introduction of a new bi-monthly Club magazine which replaced the former monthly edition. I think the editor John Jeremy, should be congratulated on the quality of this production.

Most members may be aware that we were spending large amounts of money keeping "Nancy K's" engine operational and that "Captain Amora's" engine "spat the dummy" right at the end of the season. We are very grateful that Eastern Engines Pty Ltd, the importer for Volvo Penta, has agreed to a sponsorship package that allows us to replace both engines at a very low price. We are hopeful that the "Captain" will be operational for the start of the new season. The installation of "Nancy K's" engine is already well underway.

As our accounting programmes were not Year 2000 compliant, the decision was taken to replace the computer and the programmes. The project was undertaken by Fred Bevis with the assistance of Charles Maclurcan and our files are already being converted to the new system.

I appreciate the help that has been given to me during the year by Vice Commodore Robert Evans, Rear Commodore Chris Oh, Treasurer Tony Saunders, Immediate Past Commodore Fred Bevis and Secretary Charles Maclurcan. In my first year in the role, the assistance of the forenamed has been most beneficial.

To Faye, Maggie, Rod, James, Robbie and Denise, on behalf of all the members, thank you for your outstanding effort during the past year.

I would also like to thank all members and Directors for their support.

FINANCE/ADMINISTRATION

Members will note that a modest profit of \$5,070 was recorded.

For the past year, total revenue decreased to \$508,464 due to it being a non Gaffers Regatta year, and total expenditure was \$503,394.

We are currently in a sound financial position with \$136,255 in cash reserves. However, this is being held for some expected very heavy expenditure on major repairs to the clubhouse, once the situation with the lease has been resolved.

Membership numbers were steady at 401.

Individual segments were as follows:

- * Administration income up to \$96,268 mainly due to interest and subscription/entry fees. Expenditure slightly up to \$87,613 a surplus of \$8,655 was recorded.
- * Racing income up to \$27,933. Expenditure shows an increase due to major expenditure on the Captain Amora. A deficit of \$37,661 was recorded.
- * Boatshed had a great improvement in income to \$287,119 due mainly to an increase in shipwright/slip sales. Expenditure increased to \$230,607 due mainly to increased depreciation for the pontoon. A surplus of \$56,512 was recorded.
- * Clubhouse income was down to \$78,505 due to the aforementioned lack of a Gaffers Regatta last financial year. Correspondingly, expenditure was also down and a reduced deficit this year of \$27,861 was recorded.
- * "The Amateurs" increased their revenue markedly to \$4,627. A much lower deficit of \$1,111 was recorded.

Overall, it is pleasing to reiterate that we are in a sound financial position, ready to effect the necessary clubhouse repairs when the need arises.

I thank Tony and Fred (my fiscal friends) for their advice and help over the past year. I also thank Faye who has been of great assistance putting up with my constant queries.

BOATSHED

The 1997/98 year saw a continuation of the staff arrangements initiated last year with additional productivity gains being made. Rod Phillips, the slipway manager, has again managed to maintain income with a further reduction in expenses.

As flagged in last year's report, this year has been the year where we brought the Club's boats up to scratch. Last winter both the "Captain Amora" and the "Nancy K" had their hulls stripped and repainted. The "Captain" also had it's interior refurbished. This winter the program is to be completed with the "Nancy K" currently sitting in a shed at Mona Vale with new decks and interior, and engine being installed and the "Captain Amora" awaiting its new engine from Sweden. Both engines are being supplied by Volvo under what is a very generous sponsorship deal for the Club. By the time all this work is finished, the Club will have a starter's boat and tender in pristine condition capable of many more years of hard work.

The year also saw a change in our tender service arrangements with Robbie White joining us a club boatman. Robbie has taken on the responsibility of looking after the day to day maintenance of the Club's boats and providing the tender service of a weekend. All members with a boat in Mosman Bay, will I am sure agree, that Robbie with his mobile phone has eliminated almost all the tender problems we have had in the past.

Last winter saw a refurbishment of the pontoon, which hopefully will give a few more years of life. Under the supervision of Bob Lawler and John Jeremy, new hinges, cross bracing and fenders were installed and the long-standing inboard droop has been rectified with an additional floatation tank.

The Club also this year, commissioned a comprehensive safety audit of our activities and we are now working through the recommendations. This will result in a safer working environment for both our members and staff.

Thanks again to all volunteers who have assisted in the running of the boatshed this year. In particular to the Lawlers, who with Bob in the lead, have provided much of the workforce for all our special projects. Also thanks to Rod, who has so competently run the yard and to Faye, who has as always, looked after the office and provided the information which has made the smooth running of the boatshed possible.

DEVELOPMENT

During the year the work to stabilise the pontoon was completed. This work however, is only a holding operation until a replacement is considered in a few years time.

The negotiation for the extension of the lease, which expires at the end of 2000, has continued during the year and recently a site visit was conducted by a departmental officer. We are advised that the paperwork necessary for the renewal is progressing and we are hopeful that something more definite will be advised shortly.

While we await the result of the lease renewal negotiations, it is difficult to undertake major expenditure on the clubhouse and on planning for the future replacement of the pontoon.

All necessary maintenance work continues and details of those works are outlined in other departmental reports.

THE CLUB YACHT

The Adams 10, known as "The Amateurs", is owned by the Club for the benefit of members. Its use is primarily to give members the opportunity to sail on a sporting type boat (which is a lot of fun), to improve their sailing skills and to introduce new people to the sailing experience.

The boat was used extensively throughout the year and competed in the SASC and CYC Winter race programs, the SASC Summer and Twilight racing and the Adams 10 National titles, as well as numerous training sessions and fun sailing days.

The (hard fought) CYC Winter series was completed with considerable success, achieving a third overall along with a number of prizes for individual races. As has been the custom, these prizes were all put into the Adams 10 raffle pool.

A major highlight in the Adams 10 race calendar was participating in the National Championships. This event was hosted by the MHYC and was originally to be raced offshore on the Manly circle. With this in mind, much of the equipment on the boat was upgraded. However, funding at the time would not allow for the purchase of a new mainsail. Mr. K. Roxborough loaned his mainsail from a recently purchased Lake Macquarie boat for which we were very grateful. This, together with a new No 1 headsail, helped the boat perform brilliantly in the first races offshore. MHYC then brought the racing back inside to the sound area and in the light and sloppy conditions, the boat was not able to perform as well as we liked.

As mentioned, the boat is used extensively so that one years sailing for "The Amateurs" is probably the equivalent of three or four years normal usage. Many people with different skill levels use the boat, so it is very important that maintenance is kept up to the mark. During the year a new No 1 headsail was purchased from MacDiarmid Sails at a very favourable rate. Raymond Forklifts donated all of the materials to construct a new boom; the Bevis family built a very classy new tiller; Sturrock's donated paints and sail fittings; and Alex Williamson donated some new headsail lead blocks. A new spinnaker pole was also purchased and the committee and crew of "The Amateurs" contributed a great deal of labour.

To fund many of the boat maintenance projects, the Adams 10 Committee ran a number of raffles throughout the season (mostly after Friday twilight races). These raised a significant amount of money and were well received, as many of the prizes were quite valuable e.g. watches, binoculars, bags and a weekend in the Hunter Valley (donated by Mr. F. Bevis).

As mentioned, "The Amateurs" is available to assist in honing members sailing/racing skills. To this end a trial program was introduced of asking visiting expert sailors (primarily sailmakers) to give us the benefit of their knowledge. This was conducted on some Friday evenings and appeared to be well received. This program of expert tuition will be pursued in the coming season. Details will be advised in the Club News. It is emphasised that this boat is available by booking through the office.

The assistance of various members of the Adams 10 Committee was much appreciated by the new boy on the block.

RACING

The SASC gathered the usual suspects and added a few new players to the racing fleets for season 1998/99. Saturday racing had a total of 55 boats racing in 4 divisions, all sailed in hard competitive Amateurs fashion with winners only emerging late in the season. Division 2 remains strong with the addition of 2 - 3 boats. The Cavalier 28's have a fleet of 15 boats. The SASC hosted their NSW Championships in a 5 race series set on a triangular course. There was a good healthy increase in the Traditional division and Division 7.

Sunday racing was a definite growth area last season with the class Metre and Gaffer divisions maintaining numbers and we saw the beginnings of a Vintage Bermudan Division that will need some building up for the next season. The Vintage Bermudans will start with the Gaffer Division next season as we try to increase numbers. Here is an opportunity for all the gentlemen sailors to bring out their classic boats in a 4 race series. The main Sunday Division was a heterogeneous mixture of 22 boats. Next year we anticipate going back to a dedicated Heavy Division and a separate Light Performance Division.

Tuesday twilight racing was an intense little 5 race series conducted in February. It produced some excellent racing in the mid-summer twilight's for those that can make a fast exit from work and join the unemployed sailing junkies. I can recommend this enjoyable series.

The format of 3 divisions in the Friday twilight's has been very successful with the early starting Division C boats crossing the line amidst Divisions A and B. John Morris on the Committee Vessel, is kept busy finishing boats but would not have it any other way.

Two boats deserve special mention. The first is the indomitable "Mark Twain" completing it's 21st Sydney to Hobart race - all done consecutively. No other boat can match this record and Hugh O'Neill has done the Club proud. Duncan Hill's "Aroona" performed creditably in winning both the Bob Brown Race and the Kelly Cup at the end of the season after gaining the Silver medal in the Sunday Division.

No member needs to be reminded of the tragic loss of Jim Lawler in this years Sydney-Hobart race, surely one of the finest men to grace this Club. It was a fitting tribute that the Lawler family continued where Jim had left off and campaigned "Charisma" to a well deserved win in the Sunday Division. Jim Lawler would be well satisfied - his spirit lives on.

The Daydream Shield with its new format of two match races for each pair over a trapezoid course, had to be aborted as the MHYC was unable to organise their yachts to defend the Shield. We will try again next year; MHYC has "set the date in concrete". Sponsorship from Porters Liquor and Avenue Road Delicatessen next year will ensure a great day of racing, and I trust, celebration.

Next season will see some important changes to the programme with some altered courses, starting area and clearer starting procedures. I would suggest that all old programmes be thrown out prior to next seasons racing.

My sincere thanks to Maggie Stewart for her tireless efforts as Sailing Secretary and to Denise Macintosh who deputised for Maggie when she had to be away. They ensure that race programmes and results came out on time and always correct.

To Vic Dibben, our Honorary Starter along with his fellow starters John Morris (Friday nights) and John Jeremy (Sundays) we owe a sincere debt of gratitude for their time and dedication and for a job well done, as always. Special mention as well to the ever reliable Russ Chapman who assists Vic on Saturdays. See you on the start line.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements are a general purpose financial report that have been prepared in accordance with applicable Accounting Standards, other mandatory professional reporting requirements and the Corporations Law. The financial statements have also been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets. The accounting policies have been consistently applied, unless otherwise stated.

The following is a summary of the material accounting policies adopted by the company in the preparation of the accounts.

Income Tax

No charge has been made in respect of income tax as the company relies on the exemption from income tax granted by Section 50-45 of the Income Tax Assessment Act 1997. Therefore, it is not appropriate to adopt the principles of tax effect accounting.

Inventories

Inventories are measured at the lower of cost and net realisable value.

Property, Plant and Equipment

Property, plant and equipment are brought to account at cost less, any accumulated depreciation. The carrying amount of property, plant and equipment is reviewed

annually by directors to ensure it is not in excess of the recoverable amounts from these assets. The recoverable amount is assessed on the basis of the expected net cash flows, which will be received from the assets employment and subsequent disposal. The expected net cash flows have not been discounted to their present value in determining recoverable amounts.

The depreciable amount of all fixed assets is depreciated on a straight line basis over their useful lives to the company commencing from the time asset is held ready for use.

Cash

For the purpose of the statement of cash flows, cash includes cash on hand and in at call deposits with banks or financial institutions.

Employee Entitlements

Provision is made for the company's liability for employee entitlements arising from services rendered by employees to balance date. Long service leave is accrued in respect of all employees with more than 5 years' service with the company.

The provision for employee entitlements has been measured at their nominal amount and is allocated between current and non-current liabilities. The current liability being the amount that is due to be paid in the ensuing twelve months. Because the company has relatively few employees, the adoption of this basis is believed to produce a result which is not materially different from the present value method prescribed by AASB 1028: Accounting for Employee Entitlements.

Contributions are made by the company to employee superannuation funds and are charged as expenses when incurred.

Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred. This basis is representative of the pattern of benefits derived from the leased property.

Receivables and Revenue Recognition

Trade debtors are recognised and revenue is taken up when the Club services have been provided to members and visitors. Sales revenue represents gross proceeds received and receivable from customers. Collectability of trade debtors is reviewed on an ongoing basis. Debts that are known to be uncollectable, are written off. A provision for doubtful debts is raised where some doubt as to collection exists.

Financial Reporting By Segments

The club operates in predominantly one industry – the promotion of amateur sailing and in one geographical area – Sydney.
